### **CURRENT PROJECTS**

**NJCBG:** Eleni is working with the architect to ensure the ADA-compliant front door automatically opens and has a push-button to exit. This prevents small children from rushing out of the building into the parking lot and the street.

**Library Centennial Celebration:** Did you know that 100 years ago, the Borough of Red Bank voted to have a public library? A centennial celebration all year long from November 2023 - November 2024 is being planned. (The Library did not open as a Public Library until January 1, 1924) The Foundation and staff will host several events.

**Foundation Board Liaison**: With Ann Ciabattoni's departure, the Foundation is seeking a member of the Library Board to sit in her place as Board Liaison to the Foundation. The Foundation meets bimonthly for regular business and more frequently as needed for more significant events and programs.

**Update Policies:** The Library is looking to update several policies to serve the public better, including the technology policy to update the price of the poster printer.

**NJLA Conference**: As an institutional member, all RBPL staff are the New Jersey Library Association members. This year, Eleni & Candyce asked staff members if they would like to attend. We had an overwhelming reply that most of our staff would like to participate on Thursday, June 1, as we request that the Library be closed to the public for this extraordinary professional development event. The Board agreed that closing on June 1st is a beneficial staff development day.

National Library Week: The Library will host various activities during National Library Week.

**IMLS Grant:** Eleni and Candyce met with the representative from SHI and OnShore Technologies to discuss details regarding the hybrid meeting room and to create an updated quote as technology has changed with

the overwhelming demand for such a service.

**LMxAC Executive Director Meeting**: Eleni & Candyce met with Eric Lozauskas, the new Director of LMxAC. He informed them of some changes to existing software the Library utilizes and the potential that LMxAC will offer IT support for member libraries, as several smaller-sized libraries have expressed interest and need such a service.
